Plaintiffs Robert-John: Foti, Joseph Leonard Neufeld, and Kenneth Augustine filed this action in propria persona on June 25, 2004, alleging violations of their constitutional rights. On September 16, 2004, defendants filed a motion to dismiss the complaint. noticing the hearing for October 27, 2004. On October 22, 2004, the parties agreed to continue the hearing date to November 10, 2004. On November 9, 2004, the day before the scheduled hearing, plaintiffs filed a first amended complaint. At the hearing, the court set a briefing schedule for a motion to dismiss the first amended complaint, and for plaintiffs' request for injunctive relief. On November 10, 2004, the court issued a written order summarizing the proceedings at the hearing.

On November 17, 2004, plaintiffs filed a motion for summary judgment. The court will not consider the motion for summary judgment before briefing has been completed on the above-referenced motion to dismiss and request for injunctive relief, and a written

decision has been issued. Accordingly, defendants need not file an opposition to the motion for summary judgment until requested to do so by the court.
