20 I, James Harrison, declare as follows:

21 1. I am an attorney currently employed by the California Correctional Peace Officers
22 Association, which represents the interests of California's state public employees identified as
23 Bargaining Unit 6.


24 2. Prior to my current employment, I represented Edward Hasbrouck in my capacity as
25 a staff attorney at the First Amendment Project in Oakland, California. In the summer of 2007, I
26 assisted Mr. Hasbrouck in making a Privacy Act request to U.S. Customs and Border Protection
27 (CBP) for records pertaining to Mr. Hasbrouck in the ATS records system.

1 3. On September 14, 2007, I mailed a letter on Mr. Hasbrouck's behalf dated September
2 13, 2007, appealing CBP's August 13, 2007, response to his Privacy Act request. That appeal letter
3 was sent by certified mail, return receipt requested, with certified mail number
4 70051160000258900956, to the address specified for any appeals by CBP in their August 13, 2007,
5 letter.

6 4. I have reviewed the exhibits attached to the Declaration of Edward Hasbrouck filed
7 in support of his summary judgment motion, and attest that Exhibit C attached thereto is a true and
